

RESOLUTION 07-04
A RESOLUTION BY THE CITY COUNCIL OF THE CITY
OF TOLAR, TEXAS, CANVASSING AND ADOPTING THE
RESULTS OF THE VOTES CAST IN THE CITY'S MAY 12,
2007 GENERAL ELECTION

BE IT REMEMBERED THAT on this the 12th day of May 2007, at a meeting of the City Council of the City of Tolar, Texas, a quorum being present, the meeting was called to order and the following business was transacted.

Upon motion it was unanimously ordered that the City Council consider the official returns of an election held in the City on the above-mentioned date, for the election of Councilmembers Place 1, 2 and 3.

WHEREUPON said official returns were opened, examined, canvassed and the results declared as follows:

WHEREAS, heretofore, the City Council of the City of Tolar, Texas, called an election to be held in the City on May 12, 2007, to elect a Councilmember Place 1, 2 and 3 for a two year term; and

WHEREAS, immediately after said election the Presiding Judge and other officials holding said election made their returns of the results thereof to the City Council as follows, and said returns being made according to law, and duly authenticated, and it being shown that written notice of said election was posted for the time and in the manner provided by law, and all other proceedings pertaining to said election having been shown to have been done and performed at and within the manner provided by law, and all papers pertaining thereto having been returned and filed with the City Council and no protest or objection being made to or regarding any matter pertaining to said election.

NOW, THEREFORE, be it resolved by the City Council of the City of Tolar, Texas, after examining said returns and opening and canvassing the votes of said election that the results of said election are as follows:

That the following numbers of votes were cast for the following named candidates for the office of Councilmember Place 1, to-wit:

NAME	TOTAL VOTES
Matt Hutsell	43
Janet Carter	37

It appearing that Matt Hutsell received a majority of all votes cast for the office of Councilmember Place 1, he is hereby declared to be elected to the office to serve a two-year term after qualifying.

That the following numbers of votes were cast for the following named candidates for the office of Councilmember Place 2, to-wit:

Charles Carroll	unopposed

It appearing that Charles Carroll was unopposed for the office of Councilmember Place 2, he is hereby declared to be elected to the office to serve a two-year term after qualifying.

That the following numbers of votes were cast for the following named candidates for the office of Councilmember Place 3, to-wit:

Lindsay Morgan	38
C. Michelle Barron	15
Kevin Fron	25

It appearing that Lindsay Morgan received a majority of all votes cast for the office of Councilmember Place 3, she is hereby declared to be elected to the office to serve a two-year term after qualifying.

IT IS FURTHER ORDERED that this canvass and declaration of results of said election be entered in the Minutes of the City Council and that said officers, after being qualified and having taken the oath, shall serve during the term commencing May 21st 2007 and thereafter until a successor is duly elected and qualified.

This Resolution, declaring the results of the election shall become effective immediately after its passage.
